INTRODUCTION

The Wellings Real Estate Income Fund identifies and partners with leading operators to make common and preferred equity investments across several private real estate asset classes. These include self-storage facilities, manufactured housing communities, multifamily apartments, light industrial, RV parks, open-air shopping centers and single-family rentals. Wellings Capital Management serves as the Registered Investment Adviser (RIA) to the Fund, while operators provide asset and property management services.

- Long-term investment horizon provides potential for compounding growth while reducing impact of short-term volatility, allowing time to ride out economic cycles



ASSET TYPE ALLOCATION




